\* Under Section 67-3-1 of the Utah Code, the State Auditor has the authority to withhold state allocated funds or the disbursement of property tax from any state taxing or fee-assessing unit, if necessary, to ensure that officials and employees in those taxing units of the state comply with state laws and procedures in the budgeting, expenditures, and financial reporting of public funds. However, some local governments do not receive any state allocated funds or property taxes, therefore, although they are delinquent in their reporting, the State Auditor is unable to withhold any funds.
