(24) the total amount of investment income which is based on the total public and state funds transferred to the PTIF by "internal" or "external" participants and which the State Treasurer has deposited into the general fund to become a part of it,

and

(25) any and all policies, rules, orders, directions, guidance, advice, memorandums,

correspondence or any other records that Tani Downing has created on paper or electronically as the Executive Director of DAS with respect to the balance of the PTIF, public funds transferred to the PTIF by "internal" or "external" participants, investment income that the State Treasurer has paid to "interal" or "external" participants in the PTIF, investment income that the State Treasurer has deposited into the general fund to become part of it or to any other matter regarding the PTIF.
