We currently have records that are responsive to your request. Personal information, such as physical addresses, email addresses, or phone numbers, has been redacted. The records will be sent electronically upon receipt of the amount cited in the attached invoice. To save on costs, we did not include correspondence directly from you, as you should have those records.

Your request for a fee waiver for the compilation of the correspondence related to our review is denied in accordance with Utah Code § 63G-2-203(2). While you claimed in your request that you were the subject of these records, you only appear in records for which you sent or were emailed to you.

It should be noted that Tani Downing was not employed by our office prior to January 2021. Any records you request for the time period prior to January 2021 should be directed to the appropriate government agency that employed Tani Downing and holds records dated prior to January 2021 that may be responsive to your request.

In addition, a few of the requested records in possession of the OSA are protected records based upon Utah Code § 63G-2-305(17) and are subject to attorney-client privilege. As such, these records cannot be provided at this time.

Pursuant to Utah Code § 63G-2-401, you have the right to appeal the response to this request to the chief administrative officer, John Dougall, Utah State Auditor. Your notice of appeal must be submitted within 30 days of the above date and must include your name, mailing address, daytime telephone number, and an explanation of the relief sought. You may also include any supporting information with your notice of appeal. Your appeal may be submitted at the address listed below.

Please note that all GRAMA requests are posted on our website as a matter of office practice (with personal information, such as address, redacted). We do this to provide transparency and accountability to the public at large.
