- (2) Any and all documentation of the State Auditor's and/or any other OSA agent's final interpretations of the OPMA with respect to UAC and its meetings records,
- (3) Any and all documentation of the State Auditor's and/or any other OSA agent's final interpretations of the GRAMA with respect to UAC and its meeting and other records,
- (4) Any and all documented correspondence of the State Auditor and/or any other agent of the OSA with the SRC in which the State Auditor and/or any such other agent determines or states an opinion upon the rights of UAC to convene secret meetings, conceal from the public the minutes of such meetings, not make audio recordings of such meetings and refuse to open any and all other records of UAC to

inspection by the public,

(5) Any and all documented correspondence of the State Auditor and/or any agent of the OSA with the SRC in which the State Auditor and/or any such other agent determines or states that the public shall be denied notice of and attendance at the meetings of UAC, denied inspection of the minutes of such meetings, denied audio recordings of such meetings and denied inspection of any and all other records of UAC,

(6) Any and all "flow charts" regarding UAC which the State Auditor and/or any other agent of the OSA has provided to the ES and/or the SRC with respect to my Appeal Req. # 2021-101 to the SRC,

and

(7) Any and all other documents other than the "flow charts" which the State Auditor and/or any other agent of the OSA has provided to the ES and/or the SRC regarding UAC and my Appeal Req. # 2021-101 to the SRC.

(VI) The State Auditor has engaged in consultation with the ES and the SRC regarding the OPMA, the GRAMA and the meeting and other records of the SWAP,

and

(VII) I believe that I have a right to know the State Auditor and/or any other agent of the OSA has engaged in consultation with the ES and/or the SRC regarding the OPMA, the GRAMA and the meeting and other records of UAC.
