If we validated this type of complaint or encountered this type of issue, we would clearly report it publicly and to the appropriate government officials. I would assume other auditors would, as well. I don't recall encountering this issue during the past 6 years. I can check with my staff on Tuesday to see whether they recall the last time the OSA encountered this issue. I don't believe that it is perceived as a high-risk audit area.
