#### BASES

**Mandy Teerlink** has denied my expedited inspection of the 10 categories of **PTIF** audit records described in my URGENT EXPEDITED REQUEST dated November 3, 2023 (**PTIF Audit Records**).

#### RELEVANT HISTORY

(1) On August 3, 2021, **Mandy Teerlink** made following decision:

*"We currently have records that are responsive to your request items. The records include communications between the State Records Committee and the Office regarding the Office's current understanding of the financial reporting status of the Statewide Association of Public Attorneys of Utah (SWAP). **These records can be sent electronically upon receipt of the amount cited in the attached invoice.**"*

The invoice included with such decision reads as follows:

*"August 3, 2021*

*Billing for costs related to fulfilling the GRAMA request dated July 17, 2021 RE SWAP:*

*Labor at Records Officer Rate (\$24.54/hr) 12.27 Labor – First 15 minutes free (6.14) Total*

*Amount Due \$ 6.13*

*Submit payment to: Office of the State Auditor Utah State Capitol Complex East Office*

*Building, Suite E310 Salt Lake City, Utah 84114-2310*

**DOCUMENTS WILL BE RELEASED ON RECEIPT OF PAYMENT"**

(2) I never paid the \$6.13 and the SWAP records were never provided to me.

## RELIEF SOUGHT

Expediently, please provide me the **PTIF Audit Records**.

**Note: I will be bringing to light in the SRC hearing tomorrow that Mandy Teerlink has illegally denied my inspection of the PTIF Audit Records based on the lie that I was provided the SWAP records on August 3, 2021 and that I owe the OSA \$6.13.**

#### **BASES FOR EXPEDITED REQUEST, RESPONSE AND INSPECTION**

(A) **96 Participants** have *defrauded and mislead the public by misreporting* to the **State Treasurer**, the **OST** and the **SMMC** that the **PTIF** is a qualified depository holding public funds transferred to the **State Treasurer** for investment purposes.

(B) **27 Participants** have *defrauded and mislead the public by misreporting* to the **State Treasurer**, the **OST** and the **SMMC** certain interest rates on the **PTIF**.

(C) **1 Participant** has not reported to the **State Treasurer**, the **OST** and the **SMMC** any interest rate on the **PTIF**.

(D) The **State Treasurer**, the **OST** and the **SMMC** conceal the **Statements of Accounts** described above in (1) from public online inspection.

(E) The **State Treasurer**, the **OST** and the **SMMC** conceal the **Deposit and Investment Reports** described above in (3) from public online inspection.

(F) The **State Treasurer**, the **OST** and the **SMMC** conceal the **monthly reports** described above in (5), (7) and (9) from public online inspection.

(G) The requests described above in (1), (3), (5), (7) and (9) are not online for public inspection in the website of the **OSA**.

(H) The audits described above in (2), (4), (6), (8) and (10) are not online for public inspection in the website of the **OSA**.

(I) On **October 31, 2023**, the **State Treasurer**, the **OST** and the **SMMC** filed with the **SRC** a petition that I'm a vexatious requester of records pertaining to the **PTIF (Petition)**.

(J) On **November 1, 2023**, I received notice from the Executive Secretary of the **SRC** that she has scheduled a hearing before the **SRC** with respect to the **Petition**.

and

(K) **By November 9, 2023 at the latest**, I want to be provided by the **Records Officer** a decision regarding the records described above in (1) - (10) in order to prepare and present to the **SRC by November 16, 2023** a statement of facts revealing that the records described above in

**(1) - (10)** were or were not ever made or have or have not been destroyed. If such decision cannot be made **by November 9, 2023 at the latest**, I will be compelled to appeal to the Executive Secretary of the **SRC** that the petition hearing not be held **until and unless I receive it**.

**REQUEST FOR WAIVER OF FEES AND FOR FEES QUOTE**

I'm hereby requesting a waiver of any staff time fees because I believe that each of the records described above in (1) - (10) are vital administrative public records.

If you intend to charge me any such fees, I'm hereby requesting that, **before you search, find, compile, format, manipulate, package, summarize, tailor and send or otherwise provide me the records described above in (1) - (10)** you grant me the administrative courtesy of *quoting* me any applicable staff time fees albeit I've requested a *waiver* of such fees.

Of course, I reserve the right to exercise my right to appeal such *quote* if you deny me the fees *waiver*.
