Office of the State Auditor Completes Investigation of Four HB 257-Related Complaints

Salt Lake City, UTAH -

The following is a statement from State Auditor John Dougall:

On May 22, the Office of the State Auditor (Office) reported that it had screened complaints related to alleged violations under HB 257, codified at Utah Code 63G-31 (Statute). Of the more than 12,000 complaints received, the overwhelming majority were frivolous at best and transparent hoaxes at worst. During the screening process, we identified five complaints that we thought might reflect a good-faith effort to attempt to make plausible allegation of a government entity's violation of Statute. We have completed our review of four of the five complaints. We were unable to substantiate the allegations in any of the four complaints, but we did note two separate issues. We have sent letters to the four entities noting the following:

- The Office received a complaint regarding Duchesne County (County). During the
 Office's investigation, the County failed to provide the Office with the County's
 required privacy compliance plan. We have reminded the County of its duty to
 adopt a compliance plan and have allowed them 30 days to do so.
- The Office received a complaint regarding the Provo School District (PSD). The
 Office determined that PSD had not yet adopted a final privacy compliance plan,
 but PSD's draft privacy compliance plan appears to address the requirements of
 Statute. We have allowed PSD 30 days to adopt the plan.
- The Office received a complaint regarding the Alpine School District (ASD). The
 Office determined that ASD had a privacy compliance plan that appears to
 comply with Statute.
- The Office received a complaint regarding the North Sevier Recreation Center (Center). The Office determined that the Center had a privacy compliance plan that appears to comply with Statute.

The Office is still reviewing the fifth complaint. In addition, the Office has received additional complaints, all of which were determined to be either frivolous or transparent hoaxes.
